The 1st year of the I CARE project

I CARE is an **ECVET pilot project** funded by the European Commission in the context of the European testing of the ECVET framework (European Credit system for Vocational Education and Training). The I CARE project focuses on the development of a methodology to facilitate labour market integration of migrant workers in the **personal care and social work sector**. The first year of the I CARE project has seen all partners involved in the core of project development and in networking and exchange activities with other projects and external stakeholders, including the participation in ECVET seminars across Europe.

background and The analysis research at the core of the Inception Phase have brought to liaht the state-of-the-art in participating countries (Italy, Germany, Romania, and Poland) in relation to the personal care and social work sector, as well as critical issues and best practices across Europe.

The **first two results** produced in this phase have been the collection and description of models and tools in participating countries, highlighting both gaps and common learning outcomes/ units, (Identification of Qualifications relating to Personal Care and Social Work in Partner Countries) and the analysis of existing ECVET related methodologies (Analysis of Existing Methodological Approaches for the Application of ECVET at the National, Regional and Sectoral Level)

Based on those premises, I CARE partners have now come to identify a **methodological approach** for establishing a common reference framework linked to ECVET.

Activities for the next year

The second year starts with the Implementation of ECVET Framework on Learning Outcomes Transfer Process among partner countries with the objective of defining the **I CARE Model**.

To this end, the following activities will be undertaken :

 Testing of the methodology for the evaluation of learning outcomes and the transfer model in Lombardy Region,
- Testing of the methodology for the evaluation of learning outcome
