I Care in the news

After the first newsletter, focused on the launch and presentation of the I CARE - Improving Mobility and Career Paths for Personal Care and Social Workers project, we now entered the core of project activities and the development phase.

The aim of this newsletter is the one of updating and reporting on the first phase of project operational development and its main results: **outputs** relating to this working phase, now available on our website, **events** and **news** from the I CARE and ECVET world

Context



The I CARE project addresses the issue of recognition of migrant workers' competences, with a focus on the personal care and social work as occupational area to be tested.

During its first operational/ development phase (Inception Phase - WP2), activities focused on developing a background analysis of the sectoral qualification systems in each participating country (Italy, Germany, Romania and Poland), which could serve as a basis for identifying а common methodological approach model in order to establish a shared reference framework linked to ECVET.

The **aim of the Inception Phase** was thus twofold:

Providing an overview of the state-of-the-art in the qualification framework

(personal care and social participating work) in countries, with a focus on the assessment of commonalities and differences between the Lombardy Sectoral Qualification System and those existing in partner countries (with particular regard to regulatory frameworks and common learning outcomes/units competences)

Identifying common methodological approach, based on the collection and analysis of existing methodologies, models and tools in participating countries, with the overall aim of defining the most suitable model for ECVET application to identified qualifications

Results

Identification of Qualifications Relating to Personal Care and Social Work in Partner Countries



The report is the first result of the I CARE project activities and it is aimed at serving as a descriptive basis to be used as a common reference framework in subsequent project stages. The presents first the report rationale and objectives of the I CARE project, including a brief description of the seven vocational qualifications (Lombardy Region qualification subsystem), which are the basis of the experimentation which should allow mutual recognition of competences among the four participating countries (Italy, Germany,

Romania, and Poland). The document further the analyses contexts and challenges to the development of ECVET in project partner countries by showing how ECVET is being implemented at the and national regional levels, characteristics outlining and implementation arrangements.

The last part of the report analyses national qualification systems by providing an in depth analysis of their structure and differences and a complete description of each professional profile according to the different national VET systems.

Analysis of Existing

The report assesses a number of **European and national ECVET projects** and describes their approaches, in order to focus on the most promising ones for the I CARE project.

The analysis of existing ECVET projects was carried out by exploiting four different kinds of data sources: ECVET Pilot Projects, German DECVET Projects, other projects implementing ECVET approaches, and official EU documents and studies on ECVET.

Two caveats and **seven suggestions** have been drawn from the analysis of the existing ECVET methodologies which will guide the development of a common methodology to be finalised in a subsequent project phase.

In the Annexes, a short Presentation Card of each analysed project is given.
